The Company is engaged in manufacture of woven tape, woven & printed labels which is the only reportable segment in terms of Accounting Standards, issued by the Institute of Chartered Accountants of India (ICAI). The Company is in the process of finalizing the Rights Issue Offer Document, which is to be filed with Securities and Exchange Board of India.
